



## LIMITED WARRANTY

ARCH ALUMINUM & GLASS WARRANTS TO ITS CUSTOMERS, WHO SHALL IN TURN PASS ON SAID WARRANTY TO ITS CUSTOMERS, CLIENTS OR PURCHASERS, THAT THE PRODUCTS SUPPLIED SHALL BE FREE FROM MAJOR MATERIAL AND/OR WORKMANSHIP DEFECTS FOR A PERIOD OF ONE (1) YEAR FROM THE DATE OF SHIPMENT PROVIDED THAT THE MATERIALS HAVE BEEN INSTALLED AND MAINTAINED ACCORDING TO ARCH'S INSTRUCTIONS AND RECOMMENDATIONS. ARCH MUST BE NOTIFIED PROMPTLY, IN WRITING, WITHIN ONE (1) YEAR OF SUCH DEFECTS. THE CUSTOMERS SOLE REMEDY FOR DEFECTIVE MATERIALS OR WORKMANSHIP IS THE REPAIR OR REPLACEMENT OF SUCH PARTS AS DEEMED NECESSARY BY ARCH ALUMINUM & GLASS CO. MATERIALS DEEMED DEFECTIVE MUST BE RETURNED TO ARCH ALUMINUM & GLASS, PRE-PAID VIA TRANSPORTATION SECURED BY THE CUSTOMER AND MUST BE PACKAGED TO PRECLUDE FURTHER DAMAGE.

ARCH ALUMINUM & GLASS WARRANTS THAT TEMPERED GLASS SUPPLIED BY ARCH WILL, AT THE TIME OF SHIPMENT, MEET THE FOLLOWING SPECIFICATIONS AS APPLICABLE: ASTM C 1048-04, CPSC 16 CFR 1201 & ANSI Z97.1 -- TAKE NOTE AND BE ADVISED THAT NO WARRANTY WILL BE EXTENDED AGAINST GLASS BREAKAGE, WHETHER SPONTANEOUS, ACCIDENTAL OR FROM ANY OTHER CAUSE.

ARCH EXPRESSLY ASSUMES ZERO RESPONSIBILITY FOR GLASS BREAKAGE, PRODUCT FAILURE DUE TO IMPROPER USAGE, INCOMPATIBILITY WITH OTHER COATINGS, SEALANTS, GASKETS, LUBRICANTS, INSULATION OR ANY OTHER MATERIALS; FAULTY INSTALLATION OR BUILDING CONSTRUCTION OR DESIGN; SCRATCHES OR ABRASIONS TO THE PRODUCT; ABNORMAL WEATHER CONDITIONS; OR DAMAGE CAUSED BY CLEANERS, SOLVENTS, ACIDS, ALKALIES OR ANY OTHER CHEMICALS USED ON OR AROUND THE GLASS. THE MANUFACTURER RESERVES THE RIGHT TO INSPECT, IN THE FIELD, ANY TEMPERED OR HEAT STRENGTHENED GLASS WHICH IS ALLEGED TO BE DEFECTIVE.

ARCH ALUMINUM'S POSITION ON THE USE OF RETROFIT FILMS IS THAT WE WILL NOT WARRANT GLASS BREAKAGE OR SEAL FAILURE. THE POTENTIAL OF GLASS BREAKAGE SHOULD BE REVIEWED WITH THE FILM SUPPLIER OR DESIGN PROFESSIONAL. FOR MORE INFORMATION, SEE OUR BULLETIN ON THE USE OF RETROFIT FILMS.
